
**ORDER NO. 1  
ESTABLISHING BRIEFING DEADLINES AND

On August 12, 2013, the Administrative Law Judge (ALJ) conducted a preliminary hearing in this proceeding. At the preliminary hearing, the ALJ heard oral argument on the party status of Environmental Stewardship, Darwyn and Marie Hanna, Bette Brown, and Andrew and Melissa Meyer (collectively, Protestants). Also, on August 12, 2013, End Op, L.P. (End Op) filed an Initial Brief on Various Landowners' Improper and Untimely Requests for Party Status and Standing (Initial Brief). The Protestants indicated that they would like the opportunity to respond to the Initial Brief. Accordingly, the ALJ adopted the following briefing schedule on party status:
