# ORDER NO. 1 SCHEDULING PREHEARING CONFERENCE AND ADDRESSING OTHER PROCEDURAL ISSUES

## I. PREHEARING CONFERENCE

On October 11, 2018, Lost Pines Groundwater Conservation District (District) referred the above-referenced docket to the State Office of Administrative Hearings (SOAH). SOAH assigned Administrative Law Judge (ALJs) Michael J. O'Malley and Laura M. Valdez as the presiding ALJs for this proceeding.

A prehearing conference will convene at 10:00 a.m., Wednesday, December 19, 2018, at the Bastrop Convention and Exhibit Center, 1408 Chestnut Street, Bastrop, Texas 78602. At the prehearing conference, the ALJs will address and discuss with the parties the following issues:

- party status;
- procedural and discovery schedule;
- pending motions;
- hearing on the merits;

ADDITION OF LOWER

- issues to be addressed in this proceeding;
- appropriate and adequate notice of this proceeding; and
- any other issues that will assist in the fair disposition of this case.

If any party or potential party has a pending motion or other issue that will need to be addressed by the ALJs at the prehearing conference, that motion or pleading shall be filed no later than December 14, 2018.

No later than December 4, 2018, the District shall provide notice of the December 19, 2018 prehearing conference to all entities and/or individuals that are required to be noticed under the District rules.

#### II. PROCEDURAL RULES

This case shall be conducted in accordance with the procedural rules of SOAH. *See* 1 Texas Administrative Code ch. 155.

## III. ELECTRONIC CASE INFORMATION SYSTEM

- A. Access through SOAH's public website. SOAH's Electronic Case Information System may be accessed from SOAH's website at <a href="www.soah.state.tx.us">www.soah.state.tx.us</a>. Click the "Electronic Case Files" link at the upper right-hand corner of SOAH's home page to enter the system.

**D. Service by e-mail.** SOAH has implemented service by email for proposals for decision, orders, and other case-related documents and communications in general docket cases. *See* SOAH's website, <a href="www.soah.state.tx.us">www.soah.state.tx.us</a>, for information and the form to request email service. Click on the "Request Service by Email" link in the Notices box.

#### IV. DISCOVERY

Discovery shall be conducted according to the Texas Rules of Civil Procedure, as supplemented by SOAH's discovery rules. *See* 1 Tex. Admin. Code § 155.251 (Subchapter F). Pursuant to SOAH's rule at 1 Texas Administrative Code § 155.251(d), discovery documents shall be served on the other parties but shall <u>not</u> be filed with the ALJs unless such materials are the subject of a discovery dispute.

The parties are expected to attempt to resolve discovery disputes; however, significant disputes which cannot be resolved should be brought to the ALJs' attention in a motion to compel. Any such motion shall include a copy of any discovery correspondence necessary for an informed ruling on the dispute.

#### V. PLEADINGS

Unless a party seeks a hearing and the motion is granted, the ALJs will rule on motions based on the written pleadings. If oral argument is granted, it shall be conducted by telephone conference, unless the ALJs specifies otherwise. Any motion must indicate that the moving party has contacted the other parties, and state the other parties' positions on the motion.
